

**Enrollment**

Availability of term classes & holiday workshops are indicated on the website.  
Please book online or via phone. If classes are fully booked – we keep a waiting list.  
Enrollment is only secure when START ART SCHOOL has received payment.

**Payment of fees**

Payment options – bank transfer, credit card, PayPal, or cash payments.  
Class fees are listed on our website.  
Payment of fees, are required to secure a place.

**Cancellation and Refunds**

START ART SCHOOL reserves the right to amend any class, teacher or schedule. In such circumstances, we endeavour to provide a substitute teacher of equal standing. Should a class have to be cancelled due to insufficient enrollments, all students enrolled in that class will be contacted, an alternative class arranged or a full refund provided.

**Tutors**

Tutors at START ART SCHOOL have valid Working with Children Checks & have read our Child Safety Code of Conduct.

**MISSED CLASSES**

There are no transfers, credits, refunds or adjustment in fees if your child misses a class without prior notice.

**CATCH UP CLASSES**

Catch up classes can be applied for, once per term, per student.  
Notice of Absents cannot be applied for retrospectively, we need to be informed prior to the class commencing.

**OUR CATCH UP WEEK runs from MONDAY - SATURDAY****WEEKDAY CLASSES - One "catch up" lesson, per child, per term.**

- On a weekday within the same week as the class missed.
- On the Saturday immediately following the class missed.
- 

**WEEKEND CLASSES - One "catch up" lesson per child, per term.**

- On the same Saturday as the missed class (in a different timeslot)
- On a weekday prior to the Saturday class that will be missed.
- On the following Saturday, as an additional 1 hour added to your child's class time.

If you do not show up for a class or meet the notice of absents requirements, no "catch up class" will be offered.

**RE- ENROLLMENT for existing term students**

Children enrolled in term classes have first option to re-enroll to the following term, on condition re-enrolment is done via the START ART SCHOOL website, by the last day of the preceding term.

An email link for re-enrolment is sent to all parents prior to the end of term.

Re-enrollment is accepted in order of applications received and will be confirmed by email.

If children are not re-enrolled it will be presumed that have relinquished their place in term class.

**Loyalty Discounts - Term Enrolled Students**

Term enrolled student receive a \$8.50 discount on each holiday class they book into.

This needs to be processed when bookings are made and cannot be applied for retrospectively.

We offer a sibling discount for Term enrolled students.

----- **SCHOOL HOLIDAY ART PROGRAM** -----

All holiday class transfers; refunds and cancellations need to be discussed via phone or email.

**Holiday Class Transfers – NO CHARGE**

You can transfer your child from one class to another within the same holiday program at NO CHARGE if there is an available place to transfer to. Confirmation of this possibility will need to be approved by the art school.

**Student Transfer - Holiday Class - NO CHARGE**

You can transfer a holiday art class booking to another child, such as a sibling or friend at any time and at NO CHARGE. Please advise the art school of the change prior to the class going ahead.

**Credits**

Credit vouchers will be provided for cancelled classes – only if application is made 7 days prior to the first day of the holiday program commencing.

Credit vouchers will only be valid for the current or immediately following holiday program, after that they expire.

**Refunds**

Refunds can be arranged however the following administration fees will apply to all refunds:

\$10 per lesson cancelled - 10 days or more prior to commencement of the 1st day of the Holiday Program.  
\$15 per lesson cancelled - 9 - 7 days prior to commencement of the 1st day of the Holiday Program.  
\$20 per lesson cancelled - 6- 3 days prior to commencement of the 1st day of the Holiday Program.  
\$30 per lesson cancelled - 72 hours prior to commencement of the 1st day of the Holiday Program.

There will be no refunds or credits if you withdraw, cancel or do not show up on the day of the class.

#### **Loyalty Discounts - Holiday Program Students**

If you make more than 6 booking in one holiday program you receive a free holiday lesson valued at \$75 for the same program or immediately following holiday program.  
We do not offer sibling discounts for Holiday art lessons.

#### **Enrollment age in Holiday Program**

We do not accept PRE-SCHOOLERS into our Holiday Art Program. If a preschooler is booked into the holiday program they will not be able to attend. The standard refund policy will apply to preschoolers who have been booked in.

#### **Art Materials**

All art materials are supplied, it is suggested that students wear clothing appropriate for art class.

#### **Photography**

At times we take photos of children's artworks. We never take a photo showing a child's face.  
Any photos taken will only be used for promotional purposes for START ART SCHOOL, (brochures, social media, editorials and our website etc.). These photos will never be sold and are used exclusively by and for START ART SCHOOL. Your consent applies as a Condition of Enrollment unless you notify us otherwise, in writing.

#### **Student conduct**

We expect all students to respect fellow START ART SCHOOL students, teachers, artworks, art materials and the all property on the premises. Discrimination on the grounds of age, race, gender, sexuality, physical or intellectual disability or religion will not be tolerated.  
If a child exhibits disruptive or inappropriate behaviour we reserve the right to request parents remove their child from a class, from the remainder of a lesson, the term or holiday program, without a refund of fees.

#### **Punctuality**

Out of respect for teachers and other students, children are requested to be punctual for class. Children should be escorted to & from the art school by a parent or guardian, signed in on arrival and collected at the end of class.

#### **Occupational Health & Safety**

If Children have an existing medical condition, allergy or disability that may affect participation in a class, please notify the START ART SCHOOL teacher at the time of enrollment.  
Children with temperatures, cold, flu or Covid symptoms will not be able to attend classes.  
Our premises have well marked emergency EXITS which the children will be made aware of.  
All START ART SCHOOL teachers have a Working With Children Clearance - WWC numbers are available on our website.

#### **Insurance**

#### **Indemnity**

Enrollment in a class indicated that you indemnify START ART SCHOOL PTY LTD, Vivienne du Toit and START ART SCHOOL staff, against all responsibility and claims, for accident, loss or injury suffered by you, your child or any of your property during the course of any activity or while on the START ART SCHOOL premises.  
It also authorizes START ART SCHOOL and its staff to obtain medical assistance for you or your child should the situation arise and that you agree to meet any expense related to this medical attention.  
It is your responsibility to notified START ART SCHOOL of any medical condition, severe allergy or disability that you or you child has that may impact you or your child/and or a fellow students during a course or art class.

#### **Activity Risks & Insurance**

If your child is injured as a result of an accident or incident while participating at START ART SCHOOL all costs associated with the injury, including medical costs are the responsibility of the parent/carer.
